- Please ensure that submission of the quotation constitutes your satisfaction that you have seen the material offered for sale and as such, you do not have objection what so ever about the material under disposal. Rates quoted will be firm and final. Revision of the quoted rates will not be allowed except is negotiated by K-Electric Limited.
- Any overwriting or any change and/or alteration in rates or elsewhere is liable to culminate in the outright rejection of the offer. In case there is any error between the amount specified in figures & words, the higher of the two will be taken for consideration. The bidders are advised to quote the rate in words also. Each offer should be accompanied with tender fee of Rs. 1,000/- (non-refundable) and 10% earnest money of the 'quoted offer price' exclusive of all applicable taxes in the shape of pay order / bank draft in favor of K-Electric Limited, which shall be refunded if the bid is not accepted. Offers without/short earnest money shall not be considered and will be liable to rejection. Offer price should clearly mention inclusion/exclusion of taxes.
