For the financial year ended December 31, 2016, SEP recorded an annual profit of RMB2.2 billion (US\$329.8 million) and an annual power generation of 34.64 TWh. As of December 31, 2016, SEP has an overall installed capacity of 9804.9 MW, with contributions of 66.08%, 21.10%, 8.15%, and 4.67% from coal power, natural gas power, wind power, and solar power respectively.
